

## TERMS AND CONDITIONS FOR ALLIANZ TRAVEL PROTECT PLAN PROMOTION (“PROMOTION TERMS”)

1. This Allianz Travel Protect Plan Promotion (“**Promotion**”) is jointly presented by Allianz Global Corporate & Specialty SE Singapore Branch (“**Allianz**”) and Standard Chartered Bank (Singapore) Limited (“**SCBSL**”). The Promotion is valid from 22<sup>nd</sup> May 2019 to 12<sup>th</sup> June 2019, both dates inclusive (“**Promotion Period**”).

### Promotion

2. Any application for Single Travel Protect Policy (“**Single Policy**”) from Allianz through SCBSL during the Promotion Period, entitles you to a 50% discount off your premium.
