

## TERMS AND CONDITIONS FOR ALLIANZ TRAVEL PROTECT PLAN PROMOTION (“PROMOTION TERMS”)

1. This Allianz Travel Protect Plan Promotion (“**Promotion**”) is jointly organised by Allianz Global Corporate & Specialty SE Singapore Branch (“**Allianz**”) and Standard Chartered Bank (Singapore) Limited (“**SCBSL**”). ### Promotion
